Common reasons why a construction worker who is registered to vote may vote absentee is if you are 60 years of age or older; or expect to be out of town working on election day. **Requesting an Absent Voter Ballot:** Your request for an absent voter ballot must be in writing and can be submitted to your city or township clerk. (For assistance in obtaining the address of your city or township clerk, see <u>https://www.Michigan.gov/vote</u>) You must request an absent voter ballot by mailing the <u>application</u>, <u>large print application</u>, a letter, a postcard, or a pre-printed application form obtained from your local clerk's office. Requests to have an absent voter ballot mailed to you must be received by your clerk no later than 2 p.m.

When you happen to call between 2 and 4pm near the close of business we run into snags verifying a fax has been received at the testing facility. <u>That could be an</u> <u>issue for you, when you travel to a facility after our business hours only to find the fax transmittal has failed.</u> We can mail you a drug test form also, it is good for 2 weeks once we print it, and that way you have the drug test authorization in hand! Please make sure you have 18 MUST Mods completed and you are current with your drug test! This is needed for Plant work.
